Thank you for considering Texas Public Safety and Investigations as a place to serve your community. By picking up this application, you have indicated an interest in protecting and saving the lives and property of the people in this community and surrounding areas. This organization is a private security, investigation, medical and fire service organization as well as a Training School (Texas Public Service Training Academy). This means we are comprised of professionals from every element of the public safety field. We are all held to the same excellent standards as public agency employees, although as an organization we are not affiliated with the state of Texas nor a political subdivision thereof and are considered a private company. This application applies to all applicants seeking volunteer, contractor, or paid employment status.

During the application process you will be expected to submit to a pre-service background check, driving record review, drug screen, physical ability test, and panel interview to be a selected to serve in this organization. After successful completion you will have an interview with the Chief who will make the final determination on selection after reviewing recommendations from the panel interview and reviewing all submitted documentation. If select you will be placed into a probationary status or cadet status will be assigned depending on your level of certification. The status of a probationary or cadet member can be revoked at any time if your progress and commitments are not deemed acceptable by the EMS Program Director & Fire Chief, Assistant Chief, or any of the Division Chiefs. During the time in probationary or cadet status, you will complete introductory and/or field training. You will be expected to schedule these with the Administration Officer.

Instructors: Having training and/or Instructor certification in their respective fields will be expected to deliver high quality instruction to public safety and private security students in both classroom and field training settings. This includes maintaining accurate records of attendance, performance, skills and other development progress reports as well as other duties as assigned.

Private Investigators: Having training in investigation, enforcement and detection of illicit activities will be expected to conduct research, analysis, evidence gathering, interrogation/interviews, surveillance, monitoring, serving official notices, executing warrants of arrest (if applicable) and report writing as it pertains to these activities as well as other duties as assigned.

Private Security & Personal Protection Officers: Having training in security operations and provide services will be expected to patrol, guard, secure, and otherwise enforce security protocols or observe/report violations thereof as it pertains to their duty assignment. These personnel are expected to document all activities and report serious incidents as well as other duties as assigned.

Public Safety Officers: Having training and certification as Firefighters, Security Officers, and EMS may be called upon at any time at their location of duty to assist with security services, grass fires, medical calls, vehicle collisions, natural disasters, structure fires, and other types of emergencies within the realm of public safety as well as other duties as assigned. .
